#### **Discussion Topic:**

In ports owned and managed by a Public Authority, the granting, renewal and/or termination of concessions is usually subjected to the requirements of fair tendering, transparency and non-discrimination. The same criteria applies to other types of public contracts

Today, there is a diversity of practices in different European ports. The enforcement of the public contracts requirements is not uniform in the EU.

The COM proposal for a directive on concessions will apply also to the port sector. What are the possible implications of this?

#### **Discussion Topic:**

The Commission is proposing an ambitious deployment of transport infrastructures – supported by a package of €32 billion – removing bottlenecks and ensuring full connectivity of ports with the hinterland. The TEN-T core network should be a reality in less than 20 years (by 2030). All proposed «EU corridors» should be in operation. Are European ports ready for this deployment? Are they supported by the national Transport authorities? A «port national strategy», evaluating transport needs at national and EU levels and ensuring good use of funding is a prerequisite. What is the state of play today in the different Member States?

#### **Discussion Topic:**

Single Market rules in the port sector should ensure an open business environment benefitting as many actors (authorities, businesses, workers and final consumer) as possible. Fair competition between ports and inside the port is the vital corollary to stimulate industrial and commercial expansion.

How the single market looks today in the port sector? Do the principles of transparency, non-discrimination and fair pricing (in cases of services provided under exclusive rights) apply adequately? How to conciliate open market rules with matters related to maritime safety and good professional standards for marine services?
