## Promoting Lifetime Careers in the Waterborne Sector

# Oceanographic services for the European regions

Operational oceanographic services in Europe have been developed jointly for about 20 years. This includes co-ordination of observing systems, exchange and management of marine data, assessment of the environmental state, and forecasting. It means production of marine/maritime knowledge for different users and temporal and spatial scales.

The practical work is organised in Regional Operational Oceanographic Systems, ROOSs, for the Baltic Sea, the Northwest Shelf, the Arctic, the Irish-Biscay-Iberia region, the Mediterranean, and the Black Sea. The ROOSs have played an important role in GMES-MyOcean, SeaDataNet, and Maritime Policy-EMODnet preparatory projects.

The workshop will present hitherto achievements, and conclude with a short open discussion to get user priorities for continued development.

# Towards coherent Maritime Spatial Planning in the Baltic Sea
